SHOWBAND CODE OF CONDUCT

As representatives of Rock Academy you all have a responsibility to adhere to the Showband Code of Conduct.

Drugs and Alcohol are not permitted at or near any Rock Academy activity. This includes rehearsals, performances, and trips/tours. The first infraction will result in expulsion from the program. While on tour, the student will not play in the performances and will be removed from the Showband program.

As our students are often acting as ambassadors for our program, they are expected at all times to act respectfully towards the venues and other performers that serve as our hosts.

All students are to act respectfully towards each other. This means that they are to look out for one another and treat their fellow student as they would wish to be treated.

TRAVEL WAIVERS

It is the policy of The Rock Academy that there is to be no alcohol or drugs used by students while traveling under the representation of The Rock Academy. Although we have a good group of parents who will be with the students most but not all of the time, RA takes no responsibility for children who violate this policy. Rock Academy also does not claim the ability to keep those students motivated to violate this policy from finding ways to drink alcohol or use drugs. By signing the waiver you recognize that we will use reasonable effort to protect and take care of all of our students.

These trips are wonderful opportunities for your child to grow and experience life in a truly unique way. As we do not allow the consumption of alcoholic beverages or drugs while the students are representing The Rock Academy, violations of our policy will have consequences. The method of enforcement of this policy will be at the discretion of the RA staff. If such behavior is discovered, the student will be forbidden to play in the concert and may be sent home.

If a Showband member is caught and in violation of this policy, he/she will NOT play at the Showband event and upon arrival home, that student will NO LONGER BE A SHOWBAND MEMBER.





TRAVEL WAIVERS

Your child has been chosen to accompany The Rock Academy on a Showband Rock Trip. This is a very special opportunity for learning more about playing music. In order to ensure that all students both learn and enjoy themselves on this trip the following rules are mandatory.

Students are expected to behave in an appropriate manner at all times during the trip. Fighting, stealing, vandalism, the commission of any crime, drug and/or alcohol abuse or possession are offenses that may result in expulsion, suspension and/or notification of parents and/or local law enforcement on the sole discretion of The Rock Academy.

Any expulsion or suspension shall be without refund or return of any money, deposit or fees paid by the student or their parents.

Students must remain with their chaperones and/or their parent (guardian) at all times during the trip. Students must follow all rules set forth by The Rock Academy including a curfew.

Leaving the group or adult chaperones at any time may result in expulsion, suspension and/or notification of parents and/or local law enforcement on the sole discretion of The Rock Academy.

The undersigned, for myself or for any minors for whom I am parent or legal guardian, do on behalf of myself and/or for such minors and on behalf of my and/or their heirs, personal representative and /or assigns, hereby agrees to release and hold harmless The Rock Academy, its members, principles, officers, agents and employees its subsidiaries, affiliates, franchisees, officers, directors, agents, employees and members from any and all damages or liabilities whatsoever arising out of or in connection with a student's violation of the school's policy on illegal alcohol and drug use, and further agrees to waive any lawsuit, claim or cause of action against the foregoing parties related to damages and liabilities occasioned by a student's violation of the policy.
